### Hours of Operation:

Available Monday – Friday, 7AM-6PM

NOTICE: A late fee is charged \$5.00 per minute, per child, if you arrive before 7:00AM or after 6:00PM. This payment will be due upon pickup of your child. Thank you for showing courtesy to our closing staff. **Note: there is no staff on campus before 7:00AM.**

### Field Trips:

On all field trip days, students are required to arrive on campus not later than 8:30 a.m.

All students are **REQUIRED** to wear their Summer Fun T-shirts on **ALL** field trips days.

Field trips are subject to change; please see your Newsletter for updates and valuable details!

Students cannot be dropped off or picked up at the field trip locations.

**Please make note of the times the bus leaves for each field trip. If you are late and miss the bus, you will not be able to attend Summer Fun that day.**

### Communication:

Summer Fun provides exciting and fun events. The child(ren)'s summer will be unforgettable. Although it happens infrequently, unavoidable circumstances or inclement weather may cause trips to be postponed. We appreciate your flexibility and understanding; we will do our very best to inform you well in advance.

**Weekly Newsletter:** This will be available every Friday to remind you of upcoming events, trips, and information to prepare you for the week to come.

**Email:** We will also email the weekly newsletter on Fridays, so please remember to keep us updated if your email information should change.

**Lunch:**

A balanced lunch is provided for 4 year olds.

*K5 and older:* **required to bring their lunch each day**

**WATER BOTTLES:** Please send a water bottle for your child with his/her name on it. It is important during these summer months to stay hydrated and healthy.

**Medications:**

All medications must be administered by the office staff. Teachers are prohibited from administering medications. A waiver must be signed by the parent or guardian, allowing medications to be dispensed. The dosage must be properly labeled and must include the age, weight of the child, and doctor's authorization.

**Naptime:**

Naptime is required for K4/K5 classes. K5 will begin with 1½ hour nap time and graduate to a 30-minute rest time by the end of the summer. The items required for naptime is a mat (at least 2 inches thick), a crib sheet to cover the mat, a blanket, and a small pillow or small stuffed animal to sleep with, please label everything with your child's name.

**Swimming & Water Fun:**

There is a \$40.00 swim fee that is due by May 31<sup>st</sup> for 2<sup>nd</sup> – 8<sup>th</sup> grade. Or on first day of attendance.

On swim days, provide your child(ren) these days with an extra set of clothing, towel, and sunscreen. Students are to wear bathing suits to school under shorts and t-shirt, or under cover-ups for girls.

**IF YOUR CHILD NEEDS TO WEAR A LIFEJACKET, YOU MUST PROVIDE ONE FOR THEM.**

**PLEASE WRITE THEIR NAME ON IT CLEARLY AND WE WILL ENSURE IT IS WORN.**

**ALL CHILDREN WILL GO THROUGH A SWIMMING TEST TO BE ABLE TO SWIM IN DEEP WATER.**

**IF YOUR CHILD DOESN'T PASS THE SWIM TEST, THEY WILL BE REQUIRED TO WEAR A LIFE JACKET ON SWIM DAYS.**

**Dress Code:**

Victory Christian School believes that students and staff have an obligation to see that our hearts are clean and pleasing to God, and that our appearance is clean and pleasing to man. Students will achieve and develop their potential in proportion to how they view themselves. Therefore, it is this program's belief that parents will accept their responsibility and students will show their respect for the guidelines expressed below.

1. Shorts are to be no shorter than fingertip length with the student standing and hands at their sides.
2. No cut offs, torn shorts, or leggings.
3. No tank tops or sleeveless of ANY KIND allowed.
4. No midriff or off the shoulder tops.
5. No items that represent any sort of magical or mystical creatures. (i.e. dragons, skulls, Harry Potter)
6. **Students are required to wear their Summer Fun T-Shirts on ALL field trip days. Rule of thumb: If they are going on a bus, they are wearing a Summer Fun T-shirt. If a child comes without a field trip shirt one will be billed to the account for \$10.**
7. Parents must provide sunscreen for their student to wear for any outside activities.  
(Parental permission must be given for staff to apply sunscreen.)
8. **ELECTRONICS ARE NOT ALLOWED ON SITE!** If electronics items or toys are brought, VCS Summer Fun will **NOT** be responsible for any lost, broken, or stolen items. **PLEASE LEAVE THEM AT HOME!**
9. All students are required to wear **both socks and tennis shoes** each day for activity involvement. Sandals may be **BROUGHT** for water days only!
10. Every student needs to bring an extra set of clothing for Water Days. Girls are required to wear one piece bathing suits.

**Please Note: If your child(ren) arrives without following the guidelines above, You will be contacted to provide a change of clothes, or to take them home.**

**Cost:**

*Registration:* Fee: **One-time fee**, \$35.00 for an individual, or \$50 for a family, is required upon acceptance of your application which includes a program T-shirt for each child. Additional shirt cost \$10.

Camp t-shirt is required for Summer Fun field trips.

*Swim Fee:* **one-time fee**, \$40 Swim Fee is required of 2<sup>nd</sup> -8<sup>th</sup> Graders attending swim field trips.

*Tuition Cost:* \$35 per day for each child.

*Tuition Payment Policy:* Payment is required **PRIOR** to your child’s attendance. **Attendance will not be allowed without payment.**

*Payments:* We accept cash or check at the Victory Activities office. Please make checks payable to Victory Christian School or VCS, and include your child(ren)’s name in the memo line. You may pay for more than one week at a time. We have a **no refund policy**. We also accept credit cards.

*T-Shirts:* Additional T-shirts are \$10.00 and students are required to wear them on every field trip day

*Lunch Fee:* No lunch fee will be charged for 4-year olds. K5 and up is required to bring their lunch.

**Code of Conduct:**

Consequences for violation of the Code of Conduct will be loss of recess, removal from classroom, suspension, and/or expulsion from VCS Summer Fun program.

1. Campers, who use, write, distribute, or possess, indecent or obscene language, literature, writing, or pictures, shall be suspended from camp. Students are expected to report vandalism.
2. Campers are not permitted to use tobacco, alcohol, or illegal drugs.
3. Running in the halls is strictly prohibited for safety reasons.
4. Horseplay and loud noise will not be permissible in the school building, on the school grounds, or while riding in school vehicles.
5. No phones, Radios and electronic games, and all toys are not to be brought on campus. No internet use at any time (i.e. NO Facebook, Twitter, Instagram or YouTube). Violating the rules can result in items being confiscated by staff and given to the program’s main office. Parent may pick up item at the office on the 1<sup>st</sup> offence; a \$10 charge will be given for the 2<sup>nd</sup> violation and \$25 for each additional time. *It’s best to leave them home.*
6. Campers will not be allowed to roam the hallways by themselves; they must be with their group or a designated buddy.
7. Campers are not allowed to fight verbally or physically.
8. Campers must refrain from any public display of affection (i.e. kissing, holding hands, embracing, etc.)
9. Only Christian music is to be played on campus or on school vehicles.
10. Gambling, in any form, will not be tolerated on or off campus.
11. Cheating, lying, or stealing are not part of the program and will not be tolerated.
12. Scoffing, scorning, offensive slang, taunting, bullying, and put-downs or disrespectful remarks or behavior are not tolerated.
13. Involvement in witchcraft, the occult, or astrology, is not allowed.
14. Campers are to remain in dress code until they are off campus.
15. The wearing of sunglasses and hats in the building is prohibited.
16. Earrings are not permitted on male students on campus. Earrings will be collected and returned at the end of the day.

**Classroom Code of Conduct:**

1. Show proper respect to counselors and others.
2. Obey those in authority
3. Wait to be acknowledged by a counselor by raising your hand.
4. The classroom must always remain clean, campers are required to participate in keeping the rooms clean.
5. Behave in ways that do not disrupt others.
6. Be responsible.

**Discipline:**

Victory Christian School believes that discipline must be ministered with love. Both discipline and learning go hand-in-hand to build character and to allow children to best develop into whole persons. It is expected that campers attending Summer Fun will put forth effort to listen and obey the voice of their “inner man” (Spirit). If your child is sent to our office for a disciplinary reason you will receive communication either by phone or a note explaining the situation and the actions which may result:

1. Loss of play time
2. Removal from the activity/classroom
3. Challenge(s) brought to attention of VCS Summer Fun Director and/or VCS principal
4. Suspension from the program
5. Expulsion from the program
